

Jennifer Wang Studio Policy



1. Student Age:

- Generally, students are above 6 years old. Special cases are accepted after assessing the student's muscle development and mental readiness for private instruction.

2. Payment:

- Payment is due at the end of the previous month for all scheduled lessons in the upcoming month.

- Rates:

- \$142.5 per 1.5-hour lesson

- \$95 per 1-hour lesson

- \$71.25 per 45-minute lesson

- \$47.5 per 30-minute lesson.

- Travel Fee: If the instructor travels to the student's location, a monthly travel fee is required to cover expenses and time lost.

- Fees:

- Within 5 km (3.11 miles) from Harvard Square - \$22.5

- 5-8 km (3.11 to 4.97 miles)- \$24

- 8-12 km (4.97 to 7.46 miles)- \$26.

- 12-15 km (7.46 to 9.32 miles)- \$28

- Students may register for lessons at Village Youth Conservatory in Watertown to avoid travel fees.

- Prompt payment is essential to maintain studio operations smoothly. A \$5 per student, per week late fee will be charged for payments not received by the first lesson of each month.

3. Cancellation Policy:

- Cancellations made with less than 24 hours' notice will result in forfeiture of the lesson fee.
- In the event of instructor cancellation, every effort will be made to offer an online lesson, reschedule, or provide a substitute teacher with the student's agreement.

4. Attendance:

- Students must arrive on time for scheduled lessons. Late arrivals may result in shortened lesson durations to avoid delays for subsequent students.
- Students are encouraged to arrive early to prepare their materials for the lesson.

5. Materials:

- Students are responsible for purchasing necessary materials, such as sheet music or instructional books, as recommended by the instructor.
- A dedicated notebook for violin study is required. While a staff music notebook is recommended, it is not mandatory.

6. Communication:

- Open communication is vital for a successful learning experience. Students and parents/guardians are encouraged to reach out with any questions, concerns, or scheduling issues via email or text.

7. Practice Expectations:

- Pupils are expected to practice and listen to assigned music at least 5 times each week, and preferably every day. Violin lessons produce meaningful results when students and parents follow the prescribed course of study in good faith.

8. Media Release:

- The instructor may record teaching sessions for online marketing and research purposes. A media release form follows:
